### What We Do

### The Purpose of Scouting

Scouting exists to actively engage and support young people in their personal development, empowering them to make a positive contribution to society.

### The Values of Scouting

As Scouts we are guided by these values:

Integrity - We act with integrity; we are honest, trustworthy and loyal.

**Respect** - We have self-respect and respect for others.

Care - We support others and take care of the world in which we live.

Belief - We explore our faiths, beliefs and attitudes.

**Co-operation** - We make a positive difference; we co-operate with others and make friends.

### The Scout Method

Scouting takes place when young people, in partnership with adults, work together based on the values of Scouting and:

- enjoy what they are doing and have fun
- take part in activities indoors and outdoors
- learn by doing
- share in spiritual reflection
- take responsibility and make choices
- undertake new and challenging activities
- make and live by their Promise.

The Group meets the Charity Commission's public benefit criteria under both the advancement of education and the advancement of citizenship or community development headings.



### Our Governance

The Group's governing documents are those of The Scout Association. They consist of a Royal Charter, which in turn gives authority to the Bye Laws of the Association and The Policy, Organisation and Rules (POR) of The Scout Association.

The Group is a trust established under its rules which are common to all Scouts.

The Trustees are appointed in accordance with the Policy, Organisation and Rules of The Scout Association.

The Group is managed by the Trustee Board, a team of volunteers who work together as 'Charity Trustees' of the Scout Group which is an educational charity. The role of the Trustee Board is to make sure our Scout Group is run safely and legally. As charity trustees they are responsible for complying with legislation applicable to charities. This includes the registration, keeping proper accounts and making returns to the Charity Commission as appropriate.

The Trustee Board currently consists of two independent representatives: the Chair and the Treasurer; together with the Group Scout Leader, plus two further volunteers. The Trustee Board meets every 3-4 months, and exists to support the Group Scout Leader in meeting the responsibilities of the office. Primary responsibilities of the Trustee Board:

- Budgeting appropriately and ensuring finances are managed;
- Ensuring Scout policies and relevant legislation is followed
- The maintenance of Group property;
- The insurance of persons, property and equipment;
- Managing risks;
- Helping the charity to operate well

In the current year (2024-25) there has been a particular emphasis on updating of policies and procedures, to ensure they are aligned with current legislation and updated Scouting governance arrangements

### **Reserves Policy**

The Group's policy on reserves is to hold sufficient resources to continue the charitable activities of the group should income and fundraising activities fall short. The Group Executive Committee considers that the group should hold a sum equivalent to 3-6 months running costs, circa £1,500.

### **Investment Policy**

The Group's Income and Expenditure is very small and as a consequence does not have sufficient funds to invest in longer-term investments such as stocks and shares. The Group has therefore adopted a low risk strategy to the investment of its funds. All funds are held in cash using only mainstream banks or building societies.

### Hardship Policy

The Group believes that every child can benefit from Scouting and seeks to be as inclusive as possible. This includes an active policy not to exclude anyone on financial grounds. The group therefore has a policy, and a budget to support any family struggling with financial hardship to pay for activities.

Overall, it is pleasing to see that we are covering our costs, despite increasing costs across the board; this is largely due to careful setting of subscription charges and a continued drive for efficiency in necessary expenditure.

### Chair of Trustees Report

Having completed nearly three years as chair of the Trustees, I remain hugely impressed at how a relatively small number of volunteers can combine to provide the amazing learning opportunities and vital life skills that the 51<sup>st</sup> Bath Scouts deliver. Whether it's a chance to do something adventurous, to explore the outdoors, or to learn real practical skills (making pancakes perhaps) our young people undoubtedly grow and develop in our care. And we want to continue to deliver those opportunities, with the avowed ambition to deliver more 'wow!' moments, and to be *the best Scout Group in Bath*.

Of course such an ambition depends upon the willingness and commitment of our volunteers in all the various roles to give their time, energy and imagination to make it all happen. A particular thanks to Group Scout Leader, Ashley Russell, who somehow manages to juggle a hugely demanding shift-based day-job with effective leadership of all our sections; and to the section leads who continue to dream up interesting things to do every week. We've had to deal with a number of changes to our section leaders in the past year, but our section leaders, section assistants and parent helpers have consistently delivered interesting, engaging section nights both indoors and outdoors, so immense thanks to all of them for getting involved and really making it happen. Thanks too to 'behind-the-scenes' helpers who support us to manage the database and make sure everything works. Finally, thanks to the trustees who meet regularly to make sure that we're doing all those things that our governance arrangements demand, even though they all have busy lives of their own.

We have updated a number of our governance documents this year, in line with changing legislation around data protection, for example, as well as keeping everything fresh and up-to-date. You can find summaries of these on our website, or ask one of the trustees if you want more information.

We have reached out looking for further volunteers, and we're really pleased that Iain McNair has answered the call, but I would encourage any member of our wider community to consider whether they could suggest someone who might be willing to stand for a trustee or indeed any other volunteer role.
